AMD is the leading cause of blindness worldwide and a rapidly growing public health concern for people over the age of 65, with the majority of blindness in these cases due to wet AMD – the most severe form of the condition. As the disease progresses, people with wet AMD may experience loss of central vision, resulting in an inability to read, drive or navigate one's own home, which may lead to a loss of independence.

"People with wet AMD often feel overwhelmed by the changes in their vision and fear the loss of their independence," said Patrick Mooney, US Head, Ophthalmology Franchise and Vice President, Novartis. "We're proud to partner with leading patient advocacy groups and a design industry expert to help support the needs of those living with, or caring for someone with, wet AMD – a disease that an estimated 1.75 million people are living with in the US."

Age-related macular degeneration (AMD) is the leading cause of blindness worldwide and a rapidly growing public health concern for people over the age of 65, with the majority of blindness in these cases due to wet AMD.<sup>1,2,3</sup> It is estimated that as many as 1.5-1.75 million people in the U.S. will be living with wet AMD next year.<sup>1</sup> There are two types of age-related macular degeneration (AMD): dry AMD and wet AMD.<sup>3</sup> Wet AMD is the type most severe and associated with rapidly worsening vision loss.<sup>3</sup> In wet AMD, abnormal blood vessels begin to form underneath the macula, the area of the retina responsible for sharp, central vision.<sup>6,7</sup>

Wet AMD is a chronic and degenerative disease, meaning it gets worse over time.<sup>3</sup> There is no cure for wet AMD.<sup>5,7</sup> As the disease progresses, vision can rapidly deteriorate and may lead to blindness.<sup>2,3</sup> Wet AMD may deprive people of their ability to perform basic activities and translate into the loss of their independence.<sup>1,5</sup>
